SDSU BMACC student, Anri Inoue, was awarded \$4,000 through the California Society of CPAs (CalCPA) San Diego Scholarship program during the spring of 2024. Inoue was nominated for the scholarship by accounting professor Yan Luo and finance professor, Yaoyi Xi after she served as a graduate assistant for both.

Accounting Lecturer Honored with a 2023 Glazer Fellowship Endowment

Accounting lecturer Narelle MacKenzie was recognized during the fall of 2023 with a Glazer Outstanding Lecturer Fellowship Endowment for her outstanding teaching and service to San Diego State University and the Fowler College of Business.

The Glazer Outstanding Lecturer Fellowship Endowment was established by SDSU alumnus, Jeffrey Glazer ('81, MBA) who lectured at the Fowler College of Business for over 20 years. Each endowment spans a two-year period and all recipients receive a commemorative award, a salary supplement, and additional funding to support their professional development activities.

MacKenzie, who began her academic career at the Fowler College of Business in 2007, teaches international and business taxation. She currently serves as a faculty representative on SDSU's Student Grievance Committee, and as an alternate member of SDSU's Lecturer Affairs Committee. Additionally, she received a Teaching Excellence Award from the college in 2022, and she was named the most influential faculty member by the top students in Fowler's MSBA Program (2020), Online Degree Completion Program (2021) and the BMACC Program (2022).

SDSU Accounting Students Are Awarded Prestigious Scholarships for Classroom Ethics and Academic Excellence

Two first-generation students in the Charles. W. Lamden School of Accountancy within SDSU's Fowler College of Business have each been awarded \$15,000 scholarships from the Public Company Accounting Oversight Board (PCAOB) based on their outstanding academic achievements and their demonstration of high ethical standards.

Jahaziel Sanchez, a BMACC 4+1 student and Meng Wang a student in the master of science in accountancy program (MSA), were nominated for the scholarships by Lin Wang (Sanchez) and Yan Luo and Valerie Li (Wang).

The PCAOB scholarships are awarded to students are likely to become financial and accounting auditors and who are attending U.S. colleges and institutions that are accredited by the Association to Advance Collegiate Schools of Business (AACSB). Over half of the recipients of PCAOB scholarship recipients come from backgrounds that are underrepresented in the accounting profession.

“As a Latino student with a passion for accounting, I am deeply thankful to the PCAOB for investing in me and the community I represent,” and Sanchez, who is the owner of SD360 Photo and a member in SDSU's Project Rebound Program. “I am honored to have been chosen to be a recipient of the PCAOB scholarship, which eradicates the stress of being able to afford my master's degree.”

“I am grateful to the PCAOB for their recognition of my achievements and for their generous award,” said Wang, who currently serves as a graduate assistant with the Charles. W. Lamden School of Accountancy. “The funding will give me greater flexibility to study for the CPA exams this spring before I launch my career as a financial auditor.”

Both Sanchez and Wang will complete their degree programs at the end of the spring semester in 2025.

Teaching Students the Soft Skills They'll Need to Succeed

Professor Yan Luo Serves as Faculty Advisor to Weber Honors Students

Accounting professor, Yan Luo, an advisor in SDSU's Weber Honors College offered guidance to two students who submitted academic research papers as part of their curriculum requirements.

Students in the Weber Honors College are required to complete a study abroad program and participate in at least one high impact experience (research, leadership, service or performance) prior to completing their undergraduate degree.

The two students, Audrey Jullien (Business) and Juliana Wherrett (Accounting) chose to pursue academic research as one of their experiences and completed their papers in the spring of 2023. Jullien submitted her research on "Examining the Impact of AI Implementation on Auditors' Cognitive Biases" and Wherrett examined the effects of diversity in organizations in her paper "Diversity Drives Success: Unleashing Innovation and Performance in Corporations."

To be part of the Weber Honors College advising team, Luo underwent a rigorous application and interview process. She was selected as a faculty advisor during the fall of 2023 and she became a mentor to Jullien and Wherrett during the spring of 2024.

Jullien is working as a congressional intern in Washington D.C. during the fall of 2024 and Wherrett will embark on study abroad experience during the spring of 2025.

Updated Curriculum Integrates AI into Undergraduate Coursework

As organizations increasingly utilize artificial intelligence (AI) in their business operations, the Charles W. Lamden School of Accountancy has enhanced its undergraduate curriculum with additional AI technologies, preparing students to be job-ready on day one.

Accounting professors Jeff Wang, Yan Luo and Valerie Li secured a \$15,000 grant from PwC to augment data analytics capabilities into three key courses: Intermediate Accounting I (ACCTG 331), Accounting Information Systems (ACCTG 333) and Auditing (ACCTG 431). The new AI enhancements will be rolled out to approximately 500 – 600 students in these classes during the 2024 -25 academic year.

The advanced AI capabilities are expected to offer significant advantages to students as they enter the job market. “By providing our students with state-of-the-art AI training, they will be equipped with the skill set to navigate the emerging technology landscape within the public accounting profession to conduct data-driven assessments,” said Wang.

Professor Yan Luo was selected to receive a 2023 Teaching Excellence Award from the Fowler College of Business. She was selected for the award for her outstanding skill in the classroom and for consistent dedication to her students.

Luo is no stranger to awards, having earned accolades from numerous organizations at SDSU, including being named “Professor of the Year” by the university’s Beta Gamma Sigma chapter (2018), Fowler’s Outstanding Faculty Contribution award (2018) and Most Influential Faculty by Fowler’s top undergraduate accounting student (2017).

Luo has made a concerted effort to integrate diversity, equity and inclusion (DEI) into her teaching and learning outcomes by giving students data analytics assignments which allow them to visualize the barriers in the accounting industry for women and underserved communities. They are then encouraged to discuss creative solutions to the issue with the objective of making them effective leaders as they enter the workplace.

Additionally, Luo has also acted as a mentor to four students who have successfully applied for the prestigious Public Company Account Oversight Board (PCAOB) scholarships, to numerous students involved in SDSU’s undergraduate research program, and to students in the Weber Honors College Research Program.

Luo received her award on March 22, 2024, when she and the other award recipients offered presentations to other Fowler faculty members outlining their perspective and approach to teaching effectiveness.
